Scheme for the Admission of Non-local Students

The College Management Committee has endorsed our application to participate in the Education Bureau (EDB)'s newly announced scheme for Direct Subsidy Scheme (DSS) schools to admit non-local students under a self-financing mode, commencing in the 2026/27 school year.

This initiative aligns with the Government's forward-looking strategy to enhance the internationalisation of Hong Kong's education sector and strengthen the city's position as a global education hub. St Stephen's College fully supports this vision and is committed to contributing meaningfully to its advancement.
